



2010 CONSIGNMENT TICKET SALES PROGRAM TICKET ORDER FORM

→ → → *Orders are due by March 1!*

In these economically difficult times, here is a simple way to generate a new or continue a revenue stream. Each ticket sold will create income with no risk of purchasing tickets up front. Return all unsold tickets for credit!

1. Ticket consignees are responsible for ALL TICKETS. Unsold tickets MUST BE RETURNED. Please pay for tickets sold on a monthly basis since IPRA in-turn is to pay amusement parks on the same schedule. (Adventureland Park will direct invoice to you each month for sold tickets. You will then in-turn mail Adventureland payment for tickets you have sold in each month).

2. Keep a record of the type of ticket sold (Individual, Ride n' Slide, etc.) for each park. IPRA will send a letter documenting all ticket serial numbers. Adventureland Park will invoice departments for the quantity of tickets sold each month with payments (less your up-charge) sent directly to Adventureland.

3. Customers purchasing tickets should pay via credit card, cash or write their checks to the local park and recreation department or agency selling the tickets. The local department or agency will in-turn then pay IPRA for sold tickets (except Adventureland Park - direct payment). If this process does not work for you, please call the IPRA office and we will make other arrangements. Tickets can be up-charged to no more than \$1.00 per ticket by the local department. *Exceptions: sell the following tickets to customers at: Blank Park Zoo Adult \$9.00, Blank Park Zoo Youth \$5.00, Noah's Ark \$27.50.*

4. To order consignment tickets to sell at your location or to supply your trip needs, fill out the form below and send it to our office. Remember, there is no initial cost as well as no upfront payments in order to receive consignment tickets. Tickets will be mailed after May 1.

5. All unsold tickets must be returned to IPRA by SEPTEMBER 15, 2010. Conversely, return unsold Adventureland Park tickets directly to the Park.
